The Abrahamic religions, also referred to as Abrahamism, are a group of monotheistic religions that claim to worship the God of Abraham, including Judaism, Christianity, Islam, and the Bahá'í Faith. The group is named after the prophet and patriarch Abraham,^{[2][3]} who is mentioned in the scriptures including the Quran, Tanakh, Bible, and Aqdas.^{[3][4]}

Jewish tradition claims the Twelve Tribes of Israel descend from Abraham's son Isaac and grandson Jacob; Islamic tradition claims that twelve Arab tribes descend from Abraham's son Ishmael; Bahá'í tradition claims descend from Abraham's wife Keturah.^{[2][5][6]} After a century of archaeological investigation, no evidence has been found for these historical patriarchs.^[7] Most scholars believe the story of Abraham originated in the 6th century BCE, and that the Book of Genesis does not represent historical events.^[7]

Israelite religion derives from the Ancient Canaanite religion of the Bronze Age, and became monotheistic in the Iron Age, around 6th century BCE.^[8] It survives in two modern forms: Judaism and Samaritanism. Christianity split from Judaism in the 1st century CE,^[2] and spread widely after being adopted as the state religion by the Roman Empire in the 4th century. Islam was founded in the 7th century CE, and was soon spread by the Umayyad Empire.^{[2][9]} Bahá'í Faith was founded in the 19th century.

Today the Abrahamic religions are one of the largest major divisions in comparative religion (along with Indian, Iranian, and East Asian religions).^[10] Christianity, Islam, and Judaism are the Abrahamic religions with the greatest numbers of adherents.^{[11][12][13]} Abrahamic religions with fewer adherents include the Bahá'í Faith,^[3] Druzism^{[3][14]} (sometimes considered a school of Ismaili Islam), Samaritanism,^[3] and Rastafari.^{[3][15][16]}

As King Khagan Bulan of Khazaria 740 AD, converted by his wife to Judaism, it was with purpose and design for the future plan was designed like a game of chess. As he was forced out of Russia and as part of being a follower of Judaism, he and his followers were forced to convert into new religions in each area of settlement and in most cases incurred the loss of their wealth to the ruling class or Monarchy. Due to the mistreatment of those of Jewish descent and the loss of all material wealth, there was a conversion to new Christian religions, mainly Catholic. As a result there was a historical letter issued known as the *1489 Constantinople Letter* written by a Nazi (The Grand Sanhedrin) Jewish High Priest. There was a conversion from the Jewish to Christian Faith in France and in Spain to the Catholic Faith with similar fates in all of the Monarchies of Europe. Basically, the conversions became part of the plan as later planned out in the Protocols of Zion.

As you understand each and every protocol, with your research you will clearly see the application and deployment of each strategy throughout history.

The goals pertinent to the protocols of Zion have been very effective throughout history and the puppets include the following individuals:

- 1. Napoleon Bonaparte 1769-1821 trained and positioned to lead France into disrupting Europe by war but also to lose against the British at the battle of Waterloo so that Nathan Rothschild sold short the Guilds only to put the London exchange in panic for a short sale, whereby, Nathan Rothschild was able to buy for pennies on the dollar all the Guilds he could becoming very rich and powerful mastering money increases to further loan funds to countries like the British Empire to collect later as its debtor and influence. Those bad laws include the following: The Revenue Act of 1913, also known as the Underwood Tariff or the Underwood-Simmons Act (chapter 16, 38 Statute 114), re-established a federal income tax in the United States and substantially lowered tariff rates. The act was sponsored by Representative Oscar Underwood, passed by the 63rd United States Congress, and signed into law by President^[1] Woodrow Wilson.

The 1913 Federal Reserve Act is legislation in the United States that created the Federal Reserve System.¹ Congress passed the Federal Reserve Act to establish economic stability in the U.S. by introducing a central bank to oversee monetary policy.

Restoring Constitutional Government to the United States

Whereas the States and the People wrote the Constitution of the United States, creating the government of the United States of America and delegating to it certain, limited powers; and

Whereas the government of the United States of America has enacted many laws which are repugnant to the Constitution of the United States; and

Whereas the government of the United States of America has vastly exceeded the limited powers delegated to it by the Constitution; and

Whereas the Supreme Court of the United States has upheld these unconstitutional acts; and

Whereas the government of the United States of America has demonstrated that it cannot be trusted to limit itself to those powers delegated to it by the Constitution; and

Whereas judging the constitutionality of laws is not a power delegated to the government of the United States of America by the states; and

Whereas judging the constitutionality of laws is not a power prohibited to the states by the Constitution;

Be It Resolved that the States and the People find it necessary and proper to exercise their reserved powers to determine the constitutionality of the acts, laws, treaties, orders, rules and regulations enacted by the government of the United States of America, and to prevent enforcement of any which they find to be unconstitutional.

To define the dollar as a fixed weight of gold.

IN THE HOUSE OF REPRESENTATIVES

Mr. Mooney of West Virginia introduced the following bill; which was referred to the Committee on Financial Services

A BILL

To define the dollar as a fixed weight of gold.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. FINDINGS.

Congress finds the following:

(1) The United States dollar has lost 30 percent of its purchasing power since 2000, and 96 percent of its purchasing power since the end of the gold standard in 1913.

(2) Under the Federal Reserve's 2 percent inflation objective, the dollar loses half of its purchasing power every generation, or 35 years.

(3) American families need long-term price stability to meet their household spending needs, save money, and plan for retirement.

(4) The Federal Reserve policy of long-term inflation has made American manufacturing uncompetitive, raising the cost of United States manufactured goods by more than 40 percent since 2000, compared to less than 20 percent in Germany and France.

(5) Between 2000 and 2010, United States manufacturing employment shrunk by one-third after holding steady for 30 years at nearly 20,000,000 jobs.

(6) The American economy needs a stable dollar, fixed exchange rates, and money supply controlled by the market, not the government.

(7) The gold standard puts control of the money supply with the market instead of the Federal Reserve.

(8) The gold standard means legal tender defined by and convertible into a certain quantity of gold.

(9) Under the gold standard through 1913 the United States economy grew at an annual average of four percent, one-third larger than the growth rate since then and twice the level since 2000.

(10) The international gold exchange standard from 1914 to 1971 did not provide for a United States dollar convertible into gold, and therefore helped cause the Great Depression and stagflation.

(11) The Federal Reserve's trickle down policy of expanding the money

supply with no demand for it has enriched the owners of financial assets but endangered the jobs, wages, and savings of blue collar workers.

(12) Restoring American middle-class prosperity requires change in monetary policy authorized to Congress in Article I, Section 8, Clause 5 of the Constitution.

SEC. 2. DEFINE THE DOLLAR IN TERMS OF GOLD.

Effective 30 months after the date of enactment of this Act—

(1) the Secretary of the Treasury (in this Act referred to as the “Secretary”) shall define the dollar in terms of a fixed weight of gold, based on that day’s closing market price of gold; and

(2) Federal Reserve Banks shall make Federal Reserve notes exchangeable with gold at the statutory gold definition of the dollar.

SEC. 3. DISCLOSURE OF HOLDING.

During the 30-month period following the date of enactment of this Act, the United States Government shall take timely and reasonable steps to disclose all of its holdings of gold, together with a contemporaneous report of any United States governmental purchases or sales, thus enhancing the ability of the market and of market participants to arrive at the fixed dollar-gold parity in an orderly fashion.

This is just a start and we must act quickly as it is believed by many that the Covid shot has negative consequences within it.
